DIRECTIONS:

General: SHAKE WELL BEFORE USE. Use this spray as a spot or crack and crevice treatment to control cockroaches, fleas, silverfish, sow bugs, and carpet beetles: spray area where these insects are found or may hide, including dark corners of rooms and closets; cracks and crevices in wall; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators and cabinets; and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

To Kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas. DO NOT spray on animals. Use outdoors only as an aid in reducing annoyance from flies and mosquitoes.
